EVENT INFORMATION:

Freed to Run 6.0 is a 6 marathons in 6 days point-to-point relay – with teams covering the distance, taking turns throughout the day. While each team member is running their section of the course, their teammates will shuttle ahead via transportation provided by Elite Parking to the next relay checkpoint and await their approaching team member.

Freed-to-Run donations are tax deductible and will go to the JALA Endowment for the Northeast Florida Medical Legal Partnership. The Baptist Health Foundation will match all donations by 125%.

Each day, relay teams will be picked-up at the Duval County Courthouse (corner of Adams St. & N. Pearl St.) and shuttled to their start line at a North Florida courthouse on a 6-marathons-in-6-days quest as follows (see daily start times/transportation schedule):

- Saturday, November 19 Baker County Courthouse, Macclenny (finishing at the Duval County Courthouse, Jacksonville)
