### 24/12 Hour Challenge Classifications

1. Individual category
2. Relay Teams (maximum 12 runners/walkers per team)
  - a. Both events follow a "go as you please" race format, allowing participants to run, walk, or crawl.
  - b. The distance covered by each team will be measured by counting the number of 1/2 mile laps they complete around the courthouse.
- c. Individuals and relay teams raise funds through our peer-to-peer fundraising portal based on a challenge to run or walk half-mile laps around the Duval County Courthouse in a period of either 12 or 24 hours.

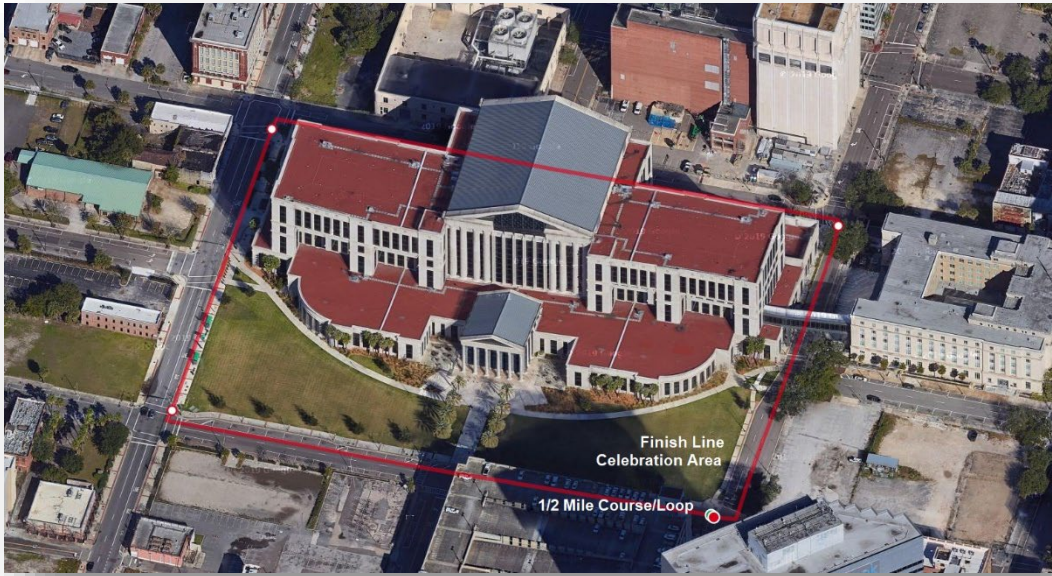
